## WHAT IS THE CERTIFICATION

The Certification of Skills allows to give formal value – so recognized - to knowledge and skills acquired, not only through school and training, but also through various experiences: from volunteering to hobby, from casual work to course offered by the neighborhood association, and so way. Also to give evidence to paths of study, carried out abroad or chosen on the basis of personal interests.

The IVC service allows, therefore, to Enhance your skills.

The minimum standard is professional profile, described in Regional directory of professions. The Dossier, which you will process with the help of a tutor expert, will be subject to evaluation, by a Regional Commission.

## IN OTHER WORDS

Then the “Certification of the Skills” is a formal procedure recognition by the holder - in our case the Liguria Region – of skills acquired by the person in all contexts, training, professional and extra professional.

The certification procedure for skills ends with the release of a qualification certificate.

The qualification has Regional value but, in many cases, is also recognized at the level National.

## THE REQUIREMENTS

Can access the service, people in Meeting the following requirements:

1. Who are of legal age, resident or domiciled in Liguria;
2. Which have matured - in the last 10 years - significant experiences, for at least 1600 hours - related to skills or a professional profile of the Directory Regional development. This experience must be from the resume or other appropriate documentation;
3. which meet the formal prerequisites and access conditions, highlighted in the format the chosen figure;

For the Citizen Non EU, is required the possession of the documentation of stay.
